

# Teaching Canadians to save themselves and rescue others

Annually, over 1,200,000 Canadians participate in our swimming, lifesaving, lifeguard, first aid and leadership programs. Each year, we certify thousands of instructors who provide the leadership for our training programs. Over 30,000 Canadians earn our Bronze Medallion each year. As Canada's lifeguarding experts, we set the standard for lifequard training and certify Canada's National Lifequards.

# Making Canadians Water Smart<sup>®</sup>

The Lifesaving Society focuses Water Smart drowning prevention efforts on people most at risk – like men fishing in small boats – or on those who can make a significant difference, such as parents of young children. We deliver Water Smart messages through our swim program, through the media and community action. Our Swim to Survive® program provides the essential minimum skills required to survive an unexpected fall into deep water.

# Drowning research

The Lifesaving Society conducts research into fatal and non-fatal drowning, aquatic injury and rescue interventions. Ongoing research and analysis supports the Society's evidence-based water-rescue training and Water Smart drowning prevention education.

# Setting the standard

The Lifesaving Society establishes aguatic safety standards and consults on aquatic safety issues for the aquatic industry, governments and the judiciary. The Society offers a suite of services to help aquatic facility operators maintain and improve safe pool and waterfront operations. We perform aquatic safety audits and serve as experts in legal cases involving aquatic safety.

# Lifesaving sport

The Lifesaving Society is the Canadian governing body for lifesaving sport – a sport recognized by the International Olympic Committee and the Commonwealth Games Federation. We use lifesaving sport to engage and inspire youth in our drowning prevention mission. Our Lifesaving Sport Fundamentals program offers a recreational introduction to lifesaving sport skills. Age-group, senior and masters athletes compete regionally, provincially, nationally and internationally. We offer certification programs for officials and coaches.

The Lifesaving Society is a full-service provider of programs, products and services designed to prevent drowning. We save lives and prevent water-related injury through our training programs, Water Smart public education, drowning research, aquatic safety management and lifesaving sport.

We are a national volunteer organization and registered charity composed of ten provincial/territorial branches, tens of thousands of individual members, and over 4,000 affiliated swimming pools, waterfronts, schools and clubs.

The Lifesaving Society is a leader and partner in the delivery of water safety education throughout Canada and around the world. (The Society operates globally in over 25 countries.) We represent Canada in the Commonwealth Royal Life Saving Society and we are Canada's Full Member in the International Life Saving Federation. The World Health Organization recognizes ILS as the world authority in the global effort to prevent drowning. The Lifesaving Society takes lead responsibility for drowning prevention in Canada.

We have been teaching swimming, water safety and water rescue in Canada since 1896. Established in England (1891) as The Swimmers' Life Saving Society, we became The Royal Life Saving Society in 1904. Today, we are known as simply the Lifesaving Society.

# **President and Chief Administrative Officer Report**

We invite you to review the 2015 annual report in its entirety and join us in celebrating the achievements and accomplishments of the past year. In January of 2016 we started a year of celebration for 125 years of drowning prevention in the Commonwealth and we look forward to our ongoing collaborative efforts and contributions for A Canada Free from Drowning and Water-Related Injury.

We are proud of the governing excellence and strategic management that continues to position the Society for being responsive to the needs of the public and provision of service enhancements for our members. The organizational succession plan continues to guide the Society into the future for ongoing growth and evolution to achieve our humanitarian mandate.

The volunteers serving on our board of directors, advisory councils, technical committees and service units; affiliate delivery partners and instructors in communities across Alberta and the Northwest Territories are essential for the capacity to provide the valuable program continuum and expert services of the Society.

More communities and individuals than ever before in Alberta and the Northwest Territories partnered and affiliated with the Society to offer the Society's learn to swim programs – Swim for Life and Canadian Swim Patrol and our government approved workplace first aid training. The value of a full spectrum program continuum, comprehensive leadership training model and service excellence is more apparent than ever.

Increased public awareness and outreach for Water Smart<sup>®</sup> education was clearly demonstrated through the use and distribution of the Society's educational standardized messages and materials to enhance existing community activations in Alberta and the Northwest Territories.

Consultation with and referral to the Society for expert opinion and recommendations as the aquatic safety experts and standard setting certifying body for lifequards in Canada was once again very apparent through the safety management services and programs that were offered throughout the year.

The benefits of our lifesaving sport system and programs that align with the long term athlete development framework, were once again demonstrated through the success of athletes, coaches and affiliate lifesaving clubs. Through fundamental lifesaving training to the pursuit of excellence we have developed a feeder system for aquatic staff and international experiences.

# **Financial Report**

The summarized financial information presented here is derived from the Royal Life Saving Society Canada, Alberta and Northwest Territories Branch Financial Statements for the year ended March 31, 2016 and independent auditor's report.

The audit did not result in any recommendations for management improvements. A letter was provided from Dentons Canada LLP confirming that as of May 18, 2016, there were no claims or possible claims outstanding.

This year realized a favourable net contribution driven mainly by delivery of more education and training programs while managing expenses. The Society develops and enhances programs and services to meet the needs of the residents of Alberta and the Northwest Territories and is well positioned to continue its mission to prevent drowning and reduce water-related injury.

# **Training Programs**

Training Programs contribute to the mission of the Society by teaching Canadians swimming and lifesaving skills and the knowledge and judgement they need to enjoy water safely and to save themselves and rescue others in an emergency.

In 2015-2016, over 250,000 Albertans and Northwest Territories residents participated in Lifesaving Society education, proficiency and training programs.

#### **Canadian Swim Patrol**

There was an increase of over 7,000 participants in the Canadian Swim Patrol program due to more programs being offered by our affiliate partners throughout communities in Alberta and the Northwest Territories.

#### Swim to Survive

There was an increase of over 6,500 participants in the Swim to Survive® program over the previous year due to additional initiatives offered by our affiliate partners and communities in Alberta and the Northwest Territories. A 125th Service Certificate was created to recognize those that contribute to a legacy of removing barriers and providing survival swimming to everyone in the Commonwealth in 2016.

#### Leadership

The Lifesaving Society delivered six (6) regional in-person leadership re-certifications and a total of 268 candidates participated. Thank you to the City of Grande Prairie (Eastlink Centre), City of Edmonton (Kinsmen Sports Centre), City of Red Deer (Collicutt Centre), the Village of Fort Simpson, Saddletowne YMCA and MacEwan University for hosting the in-person leadership recertifications.

The Society certified nearly one thousand (1000) more Swim, Lifesaving, Education and Proficiency instructors this year.

### First Aid/CPR

The Lifesaving Society is approved as First Aid/ CPR Provider by the Government of Alberta and the Government of Northwest Territories. More workplace first aid training is occurring. Nearly three thousand (3,000) more people were trained in Lifesaving Standard First Aid/ CPR than the previous year.

The Lifesaving Society is a member of the Canadian Consensus Task Force who released new guidelines for First Aid in February 2016. The new guidelines are not a suggestion that old methods are ineffective, incorrect, or dangerous, but reflect new techniques and approaches with proven benefits and improved outcomes. Lifesaving First Aid programs continue to be taught using existing program content until resources and instructors are updated.

## **Education and Proficiency**

A new Education and Proficiency program was launched in 2015: SwimAbilities Proficiency. The City of Calgary piloted this program with seven (7) instructors and is currently piloting the program with great success.

The Lifesaving Society also offers several attendant programs including Amenity Attendant, Shallow Water Attendant, and Beach Attendant. A total of four hundred and sixty (460) participated in the LS Attendant Programs, sixty nine (69) more than the previous year.

### **Boat Operator Accredited Training BOAT™**

The Lifesaving Society is accredited by Transport Canada to deliver boating safety courses and administer tests for the issuance of Pleasure Craft Operator Cards, including replacement cards, under the Competency of Operators or Pleasure Craft Regulations. The Society sent out the new January 1, 2016 – December 31, 2017 PCOC tests to affiliates offering the program.

The Society saw an increase in the BOAT program over last year as we are supporters of other regions throughout Canada.

# **Public Education**

Public Education activities contribute to the mission of the Society by increasing awareness of the risks associated with activities in, on and around water and ice. The Lifesaving Society's Public Education focus is on individuals who are unaware of Water Smart<sup>®</sup> education, as well as on those who can make a difference, such as parents of young children. The Lifesaving Society delivers Water Smart<sup>®</sup> education through the Society's swim programs, the media and various community action initiatives. The aim is to modify Alberta and Northwest Territories residents at-risk behaviors to eliminate drowning and water-related injury.

## Water Smart<sup>®</sup> Campaign


The Lifesaving Society's Water Smart campaign is an annual campaign aimed at promoting standardized public education messages through initiatives, such as Lifejacket Loaner Station programs, the Northwest Territories Water Smart program and National Drowning Prevention Week. Society members are engaged to raise awareness through enhancing existing initiatives or creating new activations in their community. The Lifesaving Society encourages all members and the public to get involved and support the Water Smart campaign. Community Activation Kits are available which include various education materials, activity guide, and a coroplast display.


#### Key Messages:

- "It happened to me, it could happen to you know before you go" – Young adults continue to have the highest water-related death rate of any age group in Canada. While taking part in high risk activities there needs to be a plan. They should be prepared and risks should be known.
- Vintage Adult " Be Active. Be Aware. Be Alive" Research has shown that drowning among older adults is increasing at home and while recreating. It's never too late to learn how to swim. No matter what your age is, know your limits. Being aware while being active can save your life.

Posters, rack cards and caregiver guidelines were created and distributed. Community activation kits were provided to 52 communities and 250 affiliates to help promote drowning prevention in their communities through standardized key messages.

The Lifesaving Society acknowledges all those that hosted or participated in community activations.





# Northwest Territories Water Smart<sup>®</sup> Program

The Lifesaving Society established a 2015 Northwest Territories Water Smart program community activation kit and distributed them as part of our annual Water Smart campaign and National Drowning Prevention Week. The Society supported 10 Water Smart community activations for the Yellowknife RCMP and Day Camps, the Pine Lake Picnic, Fred Henne and Hay Rlver Beach Programs and the Lutsel K'e Health Centre.

# Northwest Territories Beach Attendant Program

In collaboration with the Department of Industry, Tourism and Investment (ITI) the Society delivered the Beach Attendant Program for its second year in the Northwest Territories. Beach Attendant in-services and training were provided to twelve (12) participants in two (2) communities in the Northwest Territories: Hay River and Yellowknife. In addition to the Beach Attendant training, participants received Swim to Survive and Water Smart leadership training.

### **National Drowning Prevention Week**

National Drowning Prevention Week (NDPW) took place across Canada from July 19-25. Affiliate delivery partners across Alberta and the Northwest Territories delivered Water Smart® activations in their communities to help promote NDPW. The Society developed a social media plan that was shared across Canada for National Drowning Prevention Week. Forty eight (48) direct social media interactions were recorded during this week.

The Epilepsy Association of Calgary created a poster for National Drowning Prevention Week in association with the Lifesaving Society to emphasize key safety messages and how to play safe and be water smart. Messages are customized to reflect how to keep someone with epilepsy safe.

### **Operation Gateway -Certificate of Appreciation**

Operation Gateway is an annual patrol by the RCMP of the Mackenzie River, River Delta and coastal waters of the Beaufort Sea, Northwest Territories. The Lifesaving Society was honored to receive a Certificate of Appreciation in regards to our 2015 partnership. The Lifesaving Society looks forward to participating and supporting community activations in 2016.

#### Research

The Lifesaving Society researches and reports on drowning and preventable water-related deaths provincially, nationally and internationally. The purpose of the drowning research is to provide a comprehensive fact base on the drowning problem to guide the Society and other organizations in developing effective drowning prevention solutions. Ongoing research and analysis supports the Society's evidence-based water rescue training and drowning prevention education.

# **Public Education**

## 2015 Canadian Drowning Report

Interim data collected from media and internet reports indicate a decline in drowning incidents in 2014 versus 2013. This trend was evident across the county with a decline of 14% for all of Canada, with only Manitoba, Newfoundland, Saskatchewan and Nunavut showing an increase in drownings in 2014 versus 2013. The statistics gathered from this research result in individuals, organizations and governments taking decisive action towards preventative measures to reduce injury and water-related death. Ultimately, these actions make our communities safer places to live, work and play.

### 2015 Northwest Territories Drowning Trends

The Northwest Territories Drowning Trends outlines the number of drownings that occurred in the NWT using data gathered from 2012-2013 media reports. Ten (10) individuals drowned in 2012-2013. Males contributed to 80% of the reported drownings. The majority of those who drowned were adults over 35 years of age. Recreational activities accounted for over 40% of drownings, with 90% of water related deaths occurring in rivers or lakes. Drownings most often occurred during the summer months (50%). Risk factors outlined included not wearing a lifejacket, being alone, thin ice and alcohol consumption.

### Alberta Drowning Report (2015 Edition)

For drownings since 2012, only preliminary, interim data from media and Internet reports were available. In Alberta, these numbers indicate that though drowning related incidents decreased from 2013 (at least 34 incidents) to 2014 (at least 28 incidents), drowning remains a serious problem in Alberta. Proper supervision of children remains the most serious concern, as eighty percent (80%) of children aged 0-12 drowned while either alone or with another minor. Males, young adults 20-29 years of age and those 60-64 years of age are also high risk groups. Drownings are most likely to occur in the summer, on weekends and in natural bodies of water such as lakes and rivers. Most incidents occurred while swimming or participating in a recreational activity near water.

#### World Conference on Drowning Prevention

The International Lifesaving Federation (ILS) announced on September 16, 2014 that Canada won the bid to host the World Conference on Drowning Prevention. The conference will be held in Vancouver, British Columbia, from October 17-19, 2017. The bid was submitted by Lifesaving Society Canada with strong support from Lifesaving Society – British Columbia and Yukon Branch. Graham Ford, ILS President, revealed the final decision at its Board of Directors Meeting held in La Motte, France. Every two years, this premier ILS event, brings together its member organizations and the world's leading researchers, practitioners and policy makers to present and discuss the newest research and thinking in drowning prevention, lifesaving sport and related fields.



## Lifejacket Loaner Station Program

The Lifesaving Society collaborated with several partners to provide the Lifejacket Loaner Station program at eighteen (18) Alberta and two (2) Northwest Territories sites. The Society would like to thank the Lifejacket Loaner Station Program committee, Parks staff and volunteers across Alberta and the Northwest Territories, the Governments of Alberta and the Northwest Territories and the Injury Prevention Centre (IPC).


# **Comprehensive Safety Audits**

Aquatic safety audits are a core safety management service, which provide a means to maximize the safety of aquatic facilities, thereby reducing the likelihood of aquatic related injury and drowning. Eleven (11) comprehensive aquatic safety audits were conducted at: Millenium Place; Trans Alta Tri Leisure Centre; Talisman Centre; Miette Hot Springs; Banff Upper Hot Springs; Radium Hot Springs; CFB Suffield; Jamie Platz YMCA; Don Wheaton YMCA; William Lutsky YMCA and Castledowns YMCA.

## **Topical Audits**

Owners and managers with concerns about specific problems or areas of a facility, making operational or facility changes or developing new facilities may wish to have a specific issue-topical audit. Topical audits will evaluate the issue(s) and provide recommendations to enhance staff and public safety. Examples of common specific issue topical audits include Lifeguard Positioning Analysis, Lighting Analysis, Design Consultation and Facility Admission Analysis. The Lifesaving Society completed:

- Lifeguard Positioning Analysis eight (8) throughout Alberta and the Northwest Territories
- Supervision, Evaluation and Enhancement (SEE) Audits – three (3) for the City of Calgary
- Facility Design Consultations two (2) throughout Alberta and the Northwest Territories
- Amenity Analysis eighteen (18) for the City of Edmonton
- Lighting Analysis one (1) for the City of Fort Saskatchewan
- Event Consultation one (1) for the City of Edmonton
- Staff Training three (3) for the Alberta Children's Hospital and the City of St. Albert

#### **Lifesaving Society Service**

In July 2015 the Lifesaving Society was honoured to recognize the efforts of STARS personnel with a service award. This award is given to individuals who have provided STARS with a minimum of four (4) years of service. The Society recognized individuals from across all STARS bases in Western Canada.

#### Website | www.lifesaving.org

The Lifesaving Society launched an updated website www.lifesaving.org in December 2015. The website provides enhanced features and functions. The website has all of the content and functionality of the previous website (find a member, find a course, post a job, etc.) with some enhanced features and the ability to search courses. Additional website enhancements will continue to be released.

There were 102,903 visits to www.lifesaving.org in 2015-2016 with approximately 800,000 pages viewed. Approximately one third were new visits to the website.

#### **Job Postings**

The Society receives hundreds of visits each month to the jobs section of the website from individuals interested in a career in aquatics. One hundred and ninety one (191) jobs were posted on the website.

#### **Members Only**

Members Only is a section of the website where affiliates and members can access resources and materials for Society programs, such as lesson plans, test sheets and other resources. The Society had four hundred and twenty six (426) individuals' sign up for Members Only.

#### **Information and Communication Services**

The Society values keeping members informed about current activities and initiatives. Communications are distributed electronically and in print. Ripples electronic newsletter is sent bi-weekly to all affiliates, facilities, leadership volunteers and those that have joined the mailing list. These communications provide members with the most current information on Society programs and news. The Society distributed fifty five (55) electronic Communiques, nineteen (19) Ripples, ten (10) media releases, and twenty five (25) promotions. The Society also conducted twenty four (24) media interviews regarding public safety and advocacy for the Society's programs.

# Jack Boddington (October 11, 1926 – April 19, 2016)

On April 19, 2016 The Lifesaving Society regretted to advise that Jack Boddington passed away peacefully at the age of 89. Jack has many Lifesaving Society Honours and Awards and has been a proud mentor, supporter and friend of the Lifesaving Society. He was an Honorary Life Member of the Branch since 1971. He was appointed to the highest Royal Life Saving Society Canada volunteer position Commonwealth Vice President in 1998. Jack was also awarded the Queens Golden Jubilee Medal in 2001 by the Branch. In 2005 Jack was recognized for his dedication to furthering sport in Alberta when he was awarded an Alberta Centennial Salute Award. He was also inducted into the Sports Hall of Fame at the Salute to Excellence Ceremony recognizing him for his outstanding lifetime achievements as an Edmontonian. Jack recertified his Bronze Medallion and Senior Resuscitation in 1998 at the age of 72, an accomplishment to be proud of, and of even greater significance is that at the age of 82, in 2008, Jack participated in our ReBronze initiative and received a commemorative Bronze Medallion. Jack had a lifelong love of swimming and took home 6 gold medals at the Canadian Masters Swimming Competition in Windsor, Ontario at the 88 years of age. Each year at the Annual General Meeting the Society presents an affiliate recognition award called the Jack Boddington Award. The Jack Boddington Award recognizes one or more deserving active volunteers who have contributed to the success of the branch in any given year.
