Annually, 1,000,000 Canadians participate in our swimming, lifesaving, lifeguard, first aid and leadership programs. Each year, we certify thousands of instructors who provide the leadership for our training programs. Over 30,000 Canadians earn our Bronze Medallion each year. As Canada's lifeguarding experts, we set the standard for lifeguard training and certify Canada's National Lifeguards.

Making Canadians Water Smart[®]

The Lifesaving Society focuses Water Smart[®] drowning prevention efforts on those at risk, such as men fishing in small boats, or on those who can make a significant difference, such as parents of young children. We deliver Water Smart[®] messages through our swim program, through the media and through community action. Our Swim to Survive[®] Program provides the essential minimum skills required to survive an unexpected fall into deep water.

Drowning research

The Lifesaving Society conducts research into fatal and non-fatal drowning, aquatic injury and rescue interventions. Ongoing research and analysis supports the Society's evidencebased water-rescue training and Water Smart[®] drowning prevention education.

Setting the standard

The Lifesaving Society establishes aquatic safety standards and consults on aquatic safety issues for the aquatic industry, governments and the judiciary. The Society offers a suite of services to help aquatic facility operators maintain and improve safe pool and waterfront operations. We perform aquatic safety audits and serve as experts in legal cases involving aquatic safety.

Lifesaving sport

The Lifesaving Society is the Canadian governing body for lifesaving sport, a sport recognized by the International Olympic Committee and the Commonwealth Games Federation. We use lifesaving sport to engage and inspire youth in our drowning prevention mission. Our Lifesaving Sport Fundamentals Program offers 'n a recreational introduction to lifesaving sport skills. Junior, senior and masters athletes compete regionally, provincially, nationally and internationally. We offer programs for officials and coaches.

The Lifesaving Society is a full-service provider of programs, products and services designed to prevent drowning. We save lives and prevent water-related injury through our training programs, Water Smart[®] public education, drowning research, aquatic safety management and lifesaving sport.

We are a national volunteer organization and registered charity composed of ten provincial/territorial branches, tens of thousands of individual members, and over 4,000 affiliated swimming pools, waterfronts, schools and clubs.

The Lifesaving Society is a leader and partner in the delivery of water safety education throughout Canada and around the world. (The Society operates globally in over 40 countries.) We represent Canada in the Commonwealth Royal Life Saving Society and as Canada's Full Member in the International Life Saving Federation (ILS). The World Health Organization recognizes ILS as the world authority in the global effort to prevent drowning. The Lifesaving Society takes lead responsibility for drowning prevention in Canada.

We have been teaching swimming, water safety and water rescue in Canada since 1896. Established in England (1891) as The Swimmers' Life Saving Society, we became The Royal Life Saving Society in 1904. Today, we are known as simply the Lifesaving Society.

President and CAO **REPORT**

The Society enjoyed another successful year in 2012 as we continued to expand our drowning prevention reach.

Strength in numbers

The Lifesaving Society Alberta and Northwest Territories boasts an extraordinary complement of volunteers – serving on our board, advisory councils and service units; providing of their time for Society and community events; and delivering our programs and services in support of our health and safety mandate for drowning and injury prevention.

More than 191,000 Albertans and Northerners participated in our training programs including a record number in both our Swim for Life® and Swim to Survive® programs. We reached Albertans and Northerners with our Water Smart® public education messages within our initiatives such as Lifejacket Loaner Stations, Get Caught Wearing Your Lifejacket and NWT Water Smart® programs. We thank our partners for supporting our 2012 Water Smart® public education campaign.

As our Financial Report makes clear, our strength in numbers includes financial health and stability.

National and International engagement

Albertans and Northerners continue to participate internationally. In April, we were delighted to host the board meeting of the International Life Saving Federation (ILS). Among the 120 Canadians in Adelaide in November were 13 athletes from Alberta competing in National Teams, Interclub and Masters World Lifesaving Championships and six other Albertans participating as officials, team management and delegates.

New National Lifeguard Program

Just in time for its 50th anniversary celebrations, the revised National Lifeguard Program was launched with a brand new look to meet the needs of Canada's aquatic community. The National Lifeguard Program remains the single industry standard for lifeguards in Alberta and the Northwest Territories – a standard that ensures our National Lifeguard supervised pools and beaches remain among the safest anywhere.

New Society Office

In 2012, the Lifesaving Society Alberta and Northwest Territories was able to purchase a home of our own. After more than 25 years at the Percy Page Centre, the Society took possession of our new office in December. We hope this move will see operations become more streamlined and effective.

Strength in our training programs comes from those who deliver it. We are spending time to ensure that we are moving forward in making our leadership training programs better. We want to ensure that the changes are reflective of the needs and challenges of today's aquatic community and reflect the best ways to deliver our programs and services in an ever-changing environment.

Financial and Fundraising **REPORT**

The summarized financial information presented here is derived from the Society's audited financial statements for the year ending March 31, 2013. The Society's 2012-2013 financial statements have been audited by Yaremchuk and Annicchiarico LLP, Chartered Accountants.

This year realized a slight revenue decrease mainly driven by securing fewer grants. Of significant note is the change in current assets and liabilities due to the down payment and loan on our new building. We continue to keep expenses in line with revenue and invest for the future. The Society is focused on its mission and health and safety mandate for drowning and injury prevention, sport, recreation and active living in Alberta and the Northwest Territories.

Making good lifeguards better

The Lifesaving Society's National Lifeguard certification is Canada's professional lifeguard standard. Since it was developed, the National Lifeguard training program has undergone periodic revisions. The latest update, introduced in June 2012, features revised test items and performance standards and incorporates the most recent international resuscitation guidelines. The updated National Lifeguard curriculum is grounded in important lifeguard competencies – judgment, knowledge, skill and fitness.

As part of the revision the Society introduced a new National Lifeguard logo, which appears on all educational and marketing support materials including the updated *Alert* manual with an *Alert Insert* featuring new or newly emphasized technical content; new National Lifeguard test sheets; a new *National Lifeguard Award Guide*, and; a series of *What's New?* communiqués highlighting changes for lifeguards, instructors and affiliates. The logo is prominently featured on the new electronic promotional artwork for affiliate brochures and websites, full-size banners and decals.

Swim to Survive®

A record 18,448 Albertans and Northerners participated in the Swim to Survive[®] Program: a 23 per cent increase from last year.

Swim to Survive[®] teaches essential skills required to survive an unexpected fall into deep water, an important first step to being safe around the water. This program is accessible to everyone, but more specifically engages children for an Active Start. Due to the program's non-traditional and flexible delivery options with decreased operational costs, it is ideal for schools, camps and youth groups.

Swim for Life®

Participation in the Society Swim Program - Swim for Life[®] continues to grow. An amazing 129,434 Albertans and Northerners were able to develop fundamental swim skills and strokes in the following programs:

Developing physical literacy through Swim to Survive[®] and Swim for Life[®], Albertans and Northerners can have an Active Start and remain active for life.




Alberta and Northwest Territories Report

Northwest Territories Water Smart[®] Program

The Lifesaving Society collaborated with the Goverment of the Northwest Territories Drowning Prevention Working Group and Transport Canada's Boating Safety Class Contribution Program (BSCP) to develop and implement a Water Smart[®] Program for communities of the Northwest Territories. This program was executed over a two-year period, commencing in April 2011 and concluding in March 2013.

In year two of the program, the Society engaged 15 northern communities who delivered the Water Smart[®] Program to 117 participants.

To allow for sustainability of the program, each community was provided a Water Smart[®] Toolkit, Boat Safety Kit and lifejackets to be used at waterfront and pool environments.

Open Water Wisdom

In an effort to reduce drowning and water-related injury, the Lifesaving Society and the Canadian Red Cross partnered to deliver the Open Water Wisdom campaign. The campaign aims to make sport, recreation and active living on Canada's lakes, rivers and coastal regions safer for children and youth (up to 19 years).

The campaign targets remote and rural communities not normally served by ongoing water safety and learn-to-swim programs, but which may have local individuals or groups who would be able to lead some awareness activity if they had the right tools.

Educational kits were developed with materials including a *Knowledge and Activity Guide*, posters, flyers and ad templates, as well as lifejackets for participating communities.

The Lifesaving Society provides leadership, engages citizens, and inspires inclusive participation towards an Active Alberta and Northwest Territories.

2012 Canadian Drowning Report

The 2012 edition of the Canadian Drowning Report was prepared in two languages for the Lifesaving Society by the Drowning Prevention Research Centre (DPRC). The Society released the report at its national annual meeting in May. It was also inserted in the Society's National Yearbook. The Drowning Report highlighted the "who, what, when, where and why" of drownings from 1995 to 2009 and presented unofficial interim data from 2010 and 2011.

2012 Drowning and Injury Prevention Profile

Annually, the Lifesaving Society Alberta and Northwest Territories publishes a profile of drownings that occur in the province and the territories. This profile is compiled from the current data from the Office of the Medical Examiner in Alberta and the Coroner's office in the Northwest Territories.

The statistics gathered from this research result in individuals, organizations and governments taking decisive action towards preventative measures to reduce injury and water-related death. Ultimately, these actions make our communities the safest places to live, work and play.

National Drowning Prevention Week

National Drowning Prevention Week in Canada took place from July 21 to 29. The Alberta and Northwest Territories Branch issued media releases that included Water Smart[®] campaign messaging towards drowning and water-realted injury.





The Lifesaving Society has a health and safety mandate for drowning and injury prevention.



Research

The Lifesaving Society has researched and reported on drowning and preventable water-related deaths provincially and nationally since 1992. The purpose of the Society's drowning research is to provide comprehensive facts on the drowning problem to guide the Society and other organizations in developing effective drowning prevention initiatives. Ongoing research and analysis supports the Society's evidence-based water-rescue training and drowning prevention education.

The Drowning Prevention Research Centre (DPRC) is the lead agency for drowning and water-incident research in Canada. The Centre conducts research into fatal and non-fatal drowning, significant aquatic injury and rescue interventions.

Alberta and Northwest Territories Statistics

Preliminary Internet and media reported drownings in Alberta and the Northwest Territories showed an increased trend of boating related deaths over the last two years. Weather data reported that July, August and September 2012 were the hottest three months Canada has recorded in 65 years. July was the hottest on record.

From 2011 to 2012, there was a 15% increase in the number of drownings in the 18 to 34 age category. Those aged 13 to 17 showed a decrease of 83%.

In 2012, drowning while boating increased 92% from the year previous.

Out of the 31 total reported drownings, 68% were males. The number of females decreased from eight (8) in 2011 to five (5) in 2012.

The Lifesaving Society conducts research to provide evidence-based education and training to establish standards and industry customs and practices.
