Dear Affiliate Delivery Partner,

The Society is a national charitable organization that works to prevent drowning and water-related injuries through swimming, lifesaving, first aid and lifeguard training programs, safety management standards and services, Water Smart® public education, and lifesaving sport initiatives. As an Affiliate Delivery Partner, you are required to pay the annual Affiliation Fee which is current for the calendar year. This year's fees are now due. If you have any questions, please contact us.

Please review the following affiliation tiers prior to making your selection.

Corresponding Partner: This is an individual or organization who would like to be associated with the society, but is not eligible to run Lifesaving Society programs nor for discounts on Lifesaving Society Services. Corresponding Partners are not voting members of the Society.

BOAT Only Affiliate Delivery Partner: This is an Affiliate Delivery Partner of the Lifesaving Society that is restricted to only running the BOAT program and PCO certification exams. This is a voting member of the Society.

Individual Affiliate Delivery Partner: defined as **one individual** who does not own or operate an aquatic facility who holds current Lifesaving Society Leadership Certification(s). The individual is under this agreement, not a company, as the signing authority. Only the individual who signs the affiliation agreement is authorized to deliver courses under this affiliation. This is a voting member of the Society.

Associate Affiliate Delivery Partner: This is a registered corporation who does not own or operate an aquatic facility. Instructors of an Associate Member are required to hold current Lifesaving Society Leadership Certification(s). Both the individual and the company are under agreement, along with the signing authority. Employees of the corporation under agreement may deliver courses under this affiliation. This is a voting member of the Society.

Aquatic Affiliate Delivery Partner (Aquatic Facilities): defined as any one of the following: responsible agency, corporation, association or organization recognized by the Lifesaving Society and are in good standing* with the Society who owns or operates one or more aquatic facilities. There is a fee selection based on the number of aquatic facilities owned by the affiliate. This is a voting member of the Society.
