

- Bronze Medallion Candidates require CPR-C
- Lifesaving Instructors teaching a Bronze Cross course must have held a National Lifeguard Certification

#### World #DrowningPrevention Day

World Drowning Prevention Day is July 25, every year.

This year's theme expands on last year's to include "Do One Thing", "Improve One Thing", and "Add One Thing" to end drowning. ### DO ONE THING

If you aren't already taking active measures towards drowning prevention, you can start with "**DO ONE THING**".

#### **IDEAS FOR ACTION**

- Share our campaign material
- Enroll for swimming and water safety classes
- Support local drowning prevention groups
- Host public events to share water safety information
- Launch a drowning prevention campaign
- Commit to delivering new drowning prevention programs
- Develop or announce new drowning prevention policies, strategies or legislation

### IMPROVE ONE THING

If you're already working on drowning prevention, then you can work to **"IMPROVE ONE THING"**.

#### **IDEAS FOR ACTION**

- Share water safety advice in your community
- Advocate for the benefits of improving your swimming and water safety skills
- Adapt and expand existing drowning prevention programs
- Identify new partners for collaboration
- Take time to evaluate and reflect on current efforts, considering how these could be improved

### ADD ONE THING

If you are already active in drowning prevention, and have a mature program or set of programs, then it's time to **"ADD ONE THING**". Consider broadening your efforts, or adding to your portfolio of action against drowning.

#### **Policies and Procedures Manual**

We are updating our Policies and Procedures manual. We will notify you once it has been published. When referencing our Policies and Procedures, we always keep the most recent copy on our the Member Services section of our website.



#### **Swim Transition**

The final day for individuals to transition is June 28, 2023. This extension applies only to individuals, not to aquatic facilities.

Red Cross Water Safety Instructors can transition their certification to a Lifesaving Society Swim Instructor certification via the <u>Lifesaving Society</u> <u>Online Academy</u>.

Seasonal facilities, we understand that you may be starting to run Lifesaving Society lessons for the first time. Please reach out to us for support – we are happy to help with whatever you need to make the transition as smooth as possible.

#### Swim for Life Program Feedback

We understand that many of our affiliates are now fully transitioned and running our Swim for Life program. We encourage you to collect feedback from your instructors and candidates at this time. The Lifesaving Society will begin to formally request feedback in the fall to assist us in program revisions.

#### **First Aid Update**

We are doing a full review of services and programs in working towards being fiscally responsible, while maximizing our value to affiliates and increasing our outreach to meet our mandate. As such, we will be putting the First Aid Rebate Program on hold starting in September. We will review the program incentive and will be contacting affiliates for stakeholder input this year.

#### April 17, 2023 - January 1, 2024

Complete the Mandatory Update via the Online Learning Academy.

- Begin using updated National Lifeguard
  Instructor Pack
- Begin using updated National Lifeguard Instructor Award Guide



#### December 31, 2023

Start running National Lifeguard (2022 revision) program.

 The previous National Lifeguard program will retire on December 31, 2023 and all new courses mus be the updated, 2022 revision.


#### January 1, 2024

All National Lifeguard Trainers and Instructors must have completed the Mandatory Update to continue delivering National Lifeguard Programs.

• It is now required that all National Lifeguard programs run the 2022 revision, with updated materials. National Lifeguard Trainers must now have completed the Mandatory Update to deliver NLI courses.

#### **CLERC** Cancellation

The Lifesaving Society Canada is undertaking a review of the Canadian Lifeguard Emergency Response Championships (CLERC) and, as such, has canceled the 2023 and 2024 Championships (Alberta/NWT and BC/ Yukon respectively).

The Society looks forward to inviting everyone back in 2025 and encourages all athletes, coaches, and clubs to continue to participate in provincial, territorial, and national competition opportunities.

# PUBLIC ED

#### Canadian Safe Boating Council (CSBC) Safe Boating Week is May 20-26, 2023

Be sure to share these key messages:

- Wear Your Lifejacket Over 80% of Canadians who drowned while boating were either not wearing their lifejacket properly or not wearing it at all.
- Be Prepared, You and Your Boat Make sure that your boat has the required safety equipment, the weather is suitable for the voyage, you have sufficient fuel, and you have filed a trip plan. Know how to use a VHF radio and what channel to call for help in your area.
- Boat Sober Whether it is alcohol, cannabis, or prescription drugs, the use of intoxicants is both irresponsible and illegal.
- Take a Boating Course If you are operating a powered recreational vessel, you should have your Pleasure Craft Operator (PCO) Card or some other proof of competency.
- Be Aware of Cold-Water Risks Cold water can severely impact your ability to swim or even just stay afloat. No matter your swimming ability, the best chance of surviving an accidental cold-water immersion is to wear your lifejacket!

# SAFETY



#### Audits, LPAs, and Consultations

The Lifesaving Society is fully booked for safety services right up until Fall 2023. We recommend booking an audit at least once every 5 years. If you are looking to book schedule a consultation with us, make sure to do it early!



#### **National Safety Standards**
