President & Executive Director Report

We are pleased to report on the successes and challenges of the 2022-2023 business year. Our dedicated staff and volunteers have worked tirelessly to carry out our mission of preventing drowning and water-related injury. Together with our members and affiliate delivery partners, we have continued to make a real difference in the lives of individuals and families across Alberta and the Northwest Territories.

In training programs, we saw a 258% increase in program activity compared to the previous year and a 14% increase compared to pre-pandemic levels. This increase includes delivery partners transitioning to the Society's Learn to Swim program and the continued expansion of our SwimAbilities program.

In public education, we expanded the number of sites with lifejacket loaner stations to 47, including 6 in the Northwest Territories. Our annual Water Smart campaign saw increased digital engagement from the target demographics.

In research, though our partnership with the University of Alberta's Injury Prevention Centre, the 2022 non-fatal drowning report was published.

In safety management, we continued serving our members and the public though delivery of aquatic safety audits, lifeguard positioning analysis, aquatic amenity analysis, and other consulting services.

In lifesaving sport, we hosted the Canadian Pool Lifesaving Championships in June 2022, the first Canadian championship since 2019. The Lifesaving World Championships took place in Riccione, Italy, on September 18 to October 2, 2022, in which our branch volunteers were instrumental in supporting the attendance of a national delegation comprised of over 100 athletes, officials, and volunteers.

Our year has not been without challenges. In Fall 2022, our board volunteers supported the leadership transition to our current Executive Director. During this transitional period, our goal was to provide stability for our existing operational staff while maintaining services and communication with our membership and partners. We engaged a third-party HR provider to consult on a recruitment and hiring process which included the public posting, screening, and interview for the Executive Director role. This process was completed successfully around the end of our business year.

An additional challenge over the past year has been rebuilding our operational capacity to prepandemic levels. At times, we observed unusual delays in shipping and award-processing services for our membership. Over the course of the year, our team capacity has increased, and our service levels have improved. We are pleased to report that the year ended with a return to the expected level of responsiveness and member service.

In governance, our volunteer Board of Directors completed our regular quarterly meetings as well as additional committee work and supplemental planning meetings. In March 2023, our board was thrilled to complete our annual workshop inperson with all directors meeting in Edmonton. We worked through the items in our annual work plan including completing a review and update of our governance policies. This policy work refreshed the framework for how the Board of Directors fulfills its stewardship role of providing organizational hindsight, oversight, and foresight.

Additionally, in June 2022, representatives of our board joined our peers from other provincial and territorial branches across the country in Winnipeg.

MB, for planning and partnering on a national level. We use these national meetings to share regional opportunities and lessons learned, with the goal of harmonizing the Canada-wide programs, policies, and public education elements that impact lifesaving and lifesaving sport. The meetings also serve as a time to strengthen relationships with our national counterparts and build a common understanding of the work and experiences shared by each branch.

This has been a rewarding year, and we are grateful for the trust and confidence placed in us as leaders in drowning and water-related injury prevention. We thank all the staff, volunteers, affiliate delivery partners, donors, and advocates who help us towards our goal of a Canada free from drownings.



The summarized financial information presented here is derived from the Royal Life Saving Society Canada, Alberta and Northwest Territories Branch Financial Statements for the year ended March 31, 2023 and independent auditor's report.

A letter was provided from Dentons Canada LLP confirming that as of May 19, 2023, there were no claims or possible claims outstanding.

This year we posted a profit of \$6,280.00. Although revenue has increased along with program participation, consumer inflation and challenges to the supply chain has also increased costs. The Society will continue to develop and enhance programs and services to meet the needs of residents of Alberta and the Northwest Territories and is well positioned to continue its mission to prevent drowning and reduce water-related injury.






Swim Transition

In January 2022, the Canadian Red Cross announced their winding down of swim and lifeguard programming to allow a shift in focus to other humanitarian issues.

To ensure Canadians continue to have access to critical water safety programs, the Red Cross and the Lifesaving Society partnered together to support a successful transition period. The Red Cross recommended its program delivery providers transition to the Society's Learn to Swim, Leadership, and Lifeguarding Programs.

The Lifesaving Society supported multiple facilities across Alberta and the Northwest territories transitioning to its programming and we look forward to continuing to do so.









In order to further support our members, and to make our swim program more accessible to those who require additional support in the water, we launched the Online Academy SwimAbilities Instructor Transition.


Online Academy & Program Growth



BOAT

The Lifesaving Society maintained accreditation with Transport Canada to provide training and testing as part of the Pleasure Craft Operator Competency Program. The Society remains committed to this partnership, appointing branch staff to an advisory group to review and make recommendations on new boating safety test questions. Affiliates are encouraged to offer the BOAT program and Transport Canada Boating Safety Tests at their facilities.






The Lifesaving Society invested in upgrading to the Wylas Swim Timing System making competition timing much more efficient, as it is easily transportable and wireless.




Water Smart® Campaign

BEWATER SMART®

The Water Smart® Campaign is an annual campaign designed to raise awareness about drowning and water-related injury prevention. Informed by research and best practices, Water Smart® focuses on standardized messages for individuals most at risk, such as boaters or beach-goers with children. We deliver Water Smart® messages through our Swim for Life® program, media, and community action.

This year, the Society continued with two digital Water Smart® Campaigns. Over the summer months, we ran a Water Safety Contest to foster engagement with members of the public and the Lifesaving Society's mandate. In the winter, we ran a 'Do One Thing' campaign to align with the World Health Organization's theme for World Drowning Prevention Day.



Lifejacket Loaner Stations

The Lifesaving Society collaborated with partners to provide the Lifejacket Loaner Station program at 6 sites including 6 in the Northwest Territories. Water Smart® rack cards were also provided at these locations as an additional resource for loaner station users. 




World Drowning Prevention Day




Statistically, the third week of July is the highest week for drownings in Canada. As such, the Lifesaving Society designates this week as National Drowning Prevention Week (NDPW) to focus community and media attention on the drowning problem and its prevention. Community Water Smart® educators may plan news releases, television and radio interviews, deliver public education, and host other events. During this week, the Society, with the support of our affiliate members, strives to increase awareness of the need for drowning prevention and remind people to make Water Smart® choices while in, on and around the water.

The Society prepared and coordinated a social media plan for Alberta and Northwest Territories that promoted daily themes and standardized messages that align with the Water Smart® Campaign messaging and the 20 Year Drowning Analysis of AB Infographic and Northwest Territories Water-Related Injury Analysis. The 2022 National Drowning Prevention Week continued to focus on key messages such as Learn to Swim, Wear a Lifejacket, Stay Sober, Get Trained, and Donate.









Anyone can drown, no one should.

On April 28, 2021, The United Nations General Assembly declared July 25 World Drowning Prevention Day to raise awareness of the importance of drowning prevention and the need for urgent action as a collective to improve water safety and reduce preventable deaths and injury.

We hosted a flag raising ceremony at the Federal Building on July 25, 2022, with an address from Dr. Kathy Belton, Associate Director of the Injury Prevention Center, and Todd Carson, President of the Lifesaving Society, Alberta and Northwest Territories Branch. We were honored to have a panel of influential speakers, many with a personal connection to drowning:

Research & Advocacy

Our work in research and advocacy maintains awareness of the drowning problem as it relates to Alberta and the Northwest Territories. By ensuring that relevant, recent data is available to our partners, affiliates, members, and the public we continue to raise awareness around drowning and water related injuries, and support informed decisions for drowning prevention. This information is further shared through our participation in the recreation community, and through special events that raise awareness of our drowning prevention mandate.



Research & Advocacy

Research


The Lifesaving Society researches and reports provincial, national, and international drownings and preventable water-related deaths. Our drowning research provides a comprehensive fact base on drowning to guide the Society and other organizations in developing effective drowning prevention solutions. Our ongoing research and analysis supports the Society's evidence-based water rescue training and drowning prevention education.

The information developed for the annual drowning reports provides some of the most comprehensive and publicly accessible information on drownings within Canada.

This year, the Society collaborated with the University of Alberta's Injury Prevention Centre to publish the following drowning reports:

- 20 Year Drowning Analysis of AB Infographic
- Northwest Territories Water-Related Injury Analysis
- 2022 Alberta Non-Fatal Drownings Report

The Society continued to face obstacles in collecting drowning data from Medical Examiner and Coroner Offices. We will continue to advocate for access to this high-quality data in future years.



Safety

Our Aquatic Safety Management Services contribute to our mission by establishing the safety standards for aquatic environments and providing the Society's position on trending topics related to aquatic safety. Our recommendations, positions, and standards assist pool owners and agents in identifying risk and choosing potential strategies to reduce drowning and water-related injuries.



Safety Management Services



Comprehensive Safety Audits

Aquatic Safety Audits are one of our core safety management services. We assess safety in aquatic facilities and offer recommendations for safety enhancement with the goal of reducing drowning and aquatic-related injuries. Owners or agents are encouraged to have an Aquatic Safety Audit completed at their facility every 5 years.

Topical Audits

Managing a facility can come with a variety of challenges. Concerns may arise about specific problems or facility areas, operational or facility changes may be required, or new facilities may need to be developed. For all these cases, our specific issue topical audits can be the critical step towards a solution. Topical audits evaluate an issue(s) and provide recommendations to enhance staff and public safety. Common specific issue topical audits include:

- Lifeguard Positioning Analysis
- Lighting Analysis
- Aquatic Facility Design Consultation
- Signage Consultation
- Safety and Supervision Review
- Amenity Analysis

In-Services

Aquatic In-service Training Sessions are one of the safety management and program support services offered by the Lifesaving Society. In-service training is critical in preparing aquatic staff for their safety management role, and the Society has the expertise in developing, accrediting, implementing, and facilitating professional programs and services to meet community and public safety needs.

Board of Directors


